



1. Name of the Trust and its location:

- 1.3 The parties hereto shall be the first Trustees and have given their consent to be appointed as such.
- 1.4 The Office timings of Trust will be 10.00 AM to 1.00 PM, 1.00 PM to 3.00 PM Lunch break and 3.00 PM to 5.00 PM.

2. Trust shall be constituted and administered in accordance with the terms and of this Deed of Trust and the rules and regulations, if any framed there under. This trust shall be a public charitable trust and the benefits of the Trust shall be available to all the people irrespective of their caste, creed, religion or sex.

3. The property of the Trust shall include:

- 3.1 Donations, contributions, settlement either from individuals, institutions or from Government.
- 3.2 Further acquisition of the properties of any kind made by the Trust.
- 3.3 A sum of Rs.1,000/- (Rupees One thousand only) contributed by each of the Trustees.

All the properties, funds, assets of the Trust shall vest in Trustees perpetually and irrevocably for the fulfillment of the aims and objects of the Trust.

4. AIMS AND OBJECTS OF THE TRUST.

The primary motto of the Trust is to create awareness about the importance of education and to facilitate the public residing in and around Ballatagi village to get good and standard education. The trust will undertake the activities like:

- 4.1 To help and assist financially educational institutions to give scholarships, assistance, awards, stipends etc., by way of tuition fees to deserving poor students irrespective of class, or community, sex, creed etc.
- 4.2 To construct and run hostels for the students and to establish and run educational institutions both residential and non-residential (Nursery, Primary and High schools) to impart education in Kannada, English and Telugu mediums, Colleges, Technical, Medical, Paramedical, Nursing, Tailoring and Craft classes and run reading room and libraries, Training centers, Research institutions and allied institutions and other relief centers for general public utility.



- 4.3 To establish and run houses for the poor to give assistance by way of food and other maintenance to poor children of all castes, creed and sex without any distinction.
- 4.4 To spread and assist in spreading education including physical, moral, scientific and technical training.
- 4.5 To establish and run free dispensaries, clinics, to give medical assistance, free supply of medicines to poor patients to all classes, creed, sex or community without any discrimination.
- 4.6 To give donation to similar charitable institutions.
- 4.7 To conduct health awareness programme and rural social activities.
- 4.8 To plan and execute projects for the improvement of socio-economic conditions of weaker sections of the society.

5. POWERS AND FUNCTIONS OF THE BOARD:

The following powers shall be vested in the Trustees for effectively carrying on the day-to-day work of the Trust. The powers vested in the Trustees can be exercised by the Board of Management from amongst the Trustees.

- 5.1 The parties hereto, who are the first trustees are empowered to co-opt Trustees so that the total number of Trustees at any time does not exceed FIVE. Each of the first Trustee is entitled to nominate any person as his/her successor to the Office of the Trustee, in the event of any vacancy arising in the office of the Trust due to death, insolvency, insanity, incapacity, resignation, removal by Board etc. The continuing Trustees may or may not co-opt other Trustees so however that the number of Trustees shall not be less than FIVE.

- 5.2 The Trustees at their desire/discretion may receive voluntary contributions by way of gifts/grants from the Public either in the form of cash or investment towards the corpus of the Trust, or towards the capital expenditure of the Trust and the same when required, shall become part and parcel of the Trust fund. The Trustees may also receive such donation for purpose of meeting the recurring expenses of the Trust and also for the purpose of carrying out the activities of the Trust and to pass valid receipt for all such donations.
- 5.3 The trust created hereby shall be irrevocable.
- 5.4 All the funds, properties, rights, demands, claims of every description belonging or pertaining to the Trust now, including, those which hereafter be acquired from time to time shall vest in the Trustees.
- 5.5 Without prejudice to the generality of the Powers vested in the Trustees and notwithstanding anything contained in the Indian Trust Act 1982 but without repugnance and subject to the provisions of the income-tax Act 1961 and Income Tax rules 1962 with particular reference to Section 13 (1) (d) and 15 (5) of the Income-Tax Act.
- 5.6 To acquire by purchase, gift, grant, exchange, lease, hire or otherwise, properties of all kind including moveable and or immovable properties and to improve and add to the corpus of the Trust and subject to the terms and conditions and covenants contained herein.
- 5.7 To purchase or otherwise acquire, stock, debenture, annuities, and securities of every other description.

- 5.8 To draw, accept, endorse, negotiate or to deal in any other way cheques, drafts, and Hundies and other negotiable instruments, shares, securities, dividends, interest warrants etc.
- 5.9 To sell, mortgage, lease out or give on licence or otherwise alienate all or any of the properties of the Trust at such time/s and for such consideration and terms as the Trustees may deem fit.
- 5.10 To invest the moneys of the Trust in such investments as is permissible under the Income-tax Act 1961 and Rules there under as they stand from time to time.
- 5.11 To cancel or vary all or any of the investments from time to time.
- 5.12 To enter into agreements contracts and to cancel or vary them.
- 5.13 To attend company meetings, stock-holders meetings and to vote therein.
- 5.14 To receive any money and to grant receipts and discharge thereof.
- 5.15 To institute, prosecute and defend all actions and proceedings including suits, appeals, reviews, revisions, execution and the like before the Government, Courts, Tribunals, Revenue, Municipal and local authorities and taxation authorities and to represent the Trust before them.
- 5.16 To enter into any compromise and to refer matters to arbitration.





5. POWERS AND FUNCTIONS OF THE BOARD:


